ARTICLE I General Provisions

§ 104-1. Definitions and word usage.

- A. Words and phrases, when used in this chapter, shall have the meaning ascribed to them in the Vehicle Code of Pennsylvania, as now in force or as hereafter amended, enacted or

reenacted, except in those instances where the context clearly indicates a different meaning.

- B. The singular shall include the plural, and the masculine shall include the feminine.
- C. The time, whenever specified in this chapter, shall be that which is generally observed by the business interests in the Borough, whether it be Eastern standard time or Eastern daylight saving time.

§ 104-2. Manner of adopting permanent traffic and parking regulations.

All traffic and future parking regulations of a permanent nature shall be enacted as ordinances or as parts of ordinances or as amendments to ordinances of the Borough.

§ 104-3. Temporary and emergency regulations.

- A. The Mayor shall have the following powers to regulate traffic and parking temporarily and in times of emergency:
 - (1) In the case of flood, fire, storm or other emergency, to establish temporary traffic and parking regulations.
 - (2) In the case of emergency or to facilitate public works, or in the case of the conduct of processions, parades or public events, to restrict or prohibit traffic or parking in limited areas for periods of not more than 72 hours.
- B. Such temporary and emergency regulations shall be enforced by the Mayor and the police of the Borough in the same manner as permanent regulations.

§ 104-4. Enforcement.

The police officers of the Borough are hereby given authority to direct traffic on the highways and streets of the Borough and the intersections thereof.

§ 104-5. Special authority of Chief of Police.

The provisions of this chapter may be temporarily suspended by the Chief of Police or the acting head of the police, and he may prescribe temporarily such other rules and regulations as traffic conditions may require.

**ARTICLE II
Traffic Regulations**

§ 104-6. Speed limits established.

Speed limits as follows are hereby established on portions of certain streets and highways in the Borough, and it shall be unlawful for any person to operate a vehicle in any such speed limit zone at a speed in excess of that hereby established therefor:

§ 104-7. Through highways.

The following streets or portions thereof, as the case may be, are hereby established as through highways, and the operator of every vehicle, upon approaching any such highway at any intersection thereof, except where such intersection may be governed by traffic signal or where the intersection has been designated and defined as a yield-right-of-way intersection, shall come to a full stop within a reasonable distance before entering such intersection:

§ 104-8. Stop intersections.

The following intersections located in the Borough are hereby declared to be stop intersections, and official stop signs shall be erected (or are hereby confirmed if heretofore erected) in such a position as to face traffic approaching the second-named street upon the first-named street. All vehicles approaching any such intersection upon the first-named street shall come to a full stop within a reasonable distance before entering said intersection:

§ 104-10. Three- and four-way stop intersections.

Parking shall be limited to one hour on any day, except Sunday, between the hours respectively hereby indicated:

§ 104-12.1. Parking prohibited during certain hours. [Added 10-3-1977 by Ord. No. 4-77]

§ 104-12.2. Handicapped parking. [Added 3-4-1996 by Ord. No. 2-96]

- A. Pennsburg Borough Council, at its discretion, may provide, at convenient and suitable locations, on-street reserved parking spaces for the handicapped and shall designate those spaces by appropriate signs. Except for persons parking vehicles lawfully bearing a handicapped or severely disabled veteran registration plate or displaying a handicapped or severely disabled veteran placard, no person shall park a vehicle in any such parking space reserved for a handicapped person or severely disabled veteran.
- B. Any person violating any provision of this section is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of not less than \$50 and not more than \$200.

§ 104-12.3. Miscellaneous parking regulations. [Added 7-2-2001 by Ord. No. 5-01]

- A. It shall be unlawful for any person to park, place, or allow to remain standing along any of the streets of the Borough of Pennsburg any truck, truck trailer, combination thereof, or any other vehicle having a weight in excess of 11,000 pounds, or a length of greater than 28 feet, or a width of more than 80 inches, or a height of greater than nine feet.
- B. It shall be unlawful for any person to park, place or allow to remain standing along any streets in the Borough of Pennsburg a dumpster, collection bin or other nonmotorized contrivance for a period in excess of 14 days except only after a permit is obtained from the Borough with adequate reflectors and safety devices placed to prevent vehicles from colliding with such temporarily placed contrivance. **[Added 10-6-2009 by Ord. No. 4-09]**

ARTICLE IV**Trucks****[Added 11-3-1975 by Ord. No. 5-75]****§ 104-13. Definitions. [Amended 11-5-2001 by Ord. No. 8-01]**

As used in this article, the following terms shall have the meanings indicated:

TRUCK — Any two-axle vehicle with a TA license tag (13,000 pounds maximum gross weight) or greater; and any and all three-axle trucks; any and all four-axle trucks; and any and all tractor-trailer combinations, not including school buses.

§ 104-14. Trucks prohibited on all Borough streets; exceptions.

- A. Trucks, as defined in this article, are prohibited from traveling on any portion of all Borough streets (not including state roads). Notice of this prohibition shall be posted at various entrances to the Borough in order to provide notice of this prohibition. **[Amended 11-3-2003 by Ord. No. 10-03]**
- B. The above prohibition to truck traffic does not apply when a truck is making a delivery or has its origin or destination located within an area on a prohibited street. Further, any

truck shall be permitted to travel on said prohibited street after obtaining permission from the Police Department.

§ 104-14.1. Certain truck turns prohibited. [Added 12-6-1999 by Ord. No. 6-99]

- A. No trucks proceeding in a northbound direction on Route 663 shall be permitted to make a right-hand turn onto Penn Street.
- B. Trucks proceeding eastbound on Tenth Street shall not be permitted to make a left-hand turn onto Long Alley. **[Added 5-7-2001 by Ord. No. 3-01]**
- C. No trucks exiting from the Penns Court Shopping Center shall be permitted to make a left-hand turn onto Long Alley. **[Added 5-7-2001 by Ord. No. 3-01]**

ARTICLE V

Penalties

[Added 4-4-1977 by Ord. No. 2-77]

§ 104-15. Violations and penalties.

- A. Unless another penalty is specifically provided for in Subsection B below, any person who shall violate any provision of this chapter shall, upon conviction, be sentenced to pay a fine of not more than \$50 and costs of prosecution, and, in the event of nonpayment of such fine and costs of prosecution, such person shall be subject to imprisonment for a period not exceeding 10 days.
- B. Any person who shall violate any provision of a section listed below shall, upon conviction, be sentenced to pay a fine of not more than that specified for violation of said section, and in the event of nonpayment of such fine and costs of prosecution, such person shall be subject to imprisonment for a period not exceeding that indicated for said section.
