### Civic Building and Maintenance Garage Renovations Project

Pennsbury Borough worked diligently with the engineering staff to design plans that would address an overwhelming list of renovations. The Civic Building renovations consisted of a new roof, new windows, exterior lighting and a modern and watertight exterior refinishing. The maintenance garage also received a major overhaul. These renovations included new siding, new garage doors, construction of a break room, office, kitchen and bathroom, as well as other interior finishings. Lastly, a new salt shed has been installed which stores and protects the road salt used in winter months.

## TRASH & RECYCLING PICK-UP

If you have any issues with your collection or to replace a broken tote, please call the Borough Office!

If trash or recycling is not picked up on schedule, leave your tote out for pickup next morning.

### TOTES ARE NOT OWNED BY THE RESIDENTS AND MUST REMAIN ON THE PROPERTY.

Trash & recycling is picked up weekly on Wednesday. All totes should be placed out for pick up with handles away from the roadway before 6:00 A.M. If possible, allow three feet between totes and keep away from cars, trees and mailboxes.

### CURBSIDE RECYCLING

All residents will use the provided recycling tote for comingled recycling.

Place empty/rinsed items directly in the tote. Do not bag recyclables.

#### ACCEPTED ITEMS:

Glass bottles and jars, aluminum and metal cans, plastic bottles and containers #1 through #7 (lids removed), junk mail, brown paper bags, magazines, newsprint and cardboard. Boxes must be broken down.

**Do Not Include:** food waste, plastic bags, polystyrene foam cups and containers, needles, tissues, paper towels, napkins & shredded paper.

### TRASH REMOVAL

Residents are required to use the Waste Management provided 96 gallon green lid tote for trash collection. Any excess trash (outside of the tote) can be in 33-gallon bags with a maximum of (2) additional bags.

**SOLID WASTE ACCEPTED:** All ordinary household trash and garbage and non-recycled materials. Tires, TV's, electronic devices and hazardous waste will NOT be accepted.

### ADDITIONAL SERVICES

**Bulk Items:** pick up of large items such as appliances, furniture, AC units, dehumidifiers, etc. are not included in your weekly trash service. Call Waste Management at (800) 869-5566 for fees or you may contact a hauler of your choice.

## BRANCH PICK-UP

Chipping takes place **every Monday** in April & October, and the 2nd Monday of each month (weather permitting) as follows:

**May 11, June 8, July 13, August 10 & September 14, 2025**

- If there is inclement weather, pickup will be the next nice day.
- Neatly place branches no larger than 2 inches in diameter at your trash pick-up location. Put small pieces in a container.
- There is a 10 minute time limit per property.
- Grass, weeds, flowers, vines, branches with fruit, lumber and downed trees (cut down or fallen trees) will not be accepted.
- **Christmas trees will be picked up every week in January.**

## STREET SWEEPING

Dates will be posted on the Borough website and Facebook or you may call the borough office.

## PERMITS, ZONING & INSPECTIONS

- Permits and inspections are required for sheds, decks, signs, fences, chimineas, driveways, roofs, additions, pools and other projects. Check our website for more information on permits & inspections required in the borough.
- Borough Codes can be found on our website via E-Codes.
- A Use & Occupancy inspection is required each time there is a change in property ownership, both residential & commercial.
- Rental units and tenants must be reported. Rental inspections are required every three years or upon a change in tenants.

## STORMWATER INFORMATION

Stormwater might not be something you think about every day, but it affects all of us. After a heavy rain, if the water has nowhere to go, it can pool on roads and in yards, creating safety issues and sometimes even damaging property. As that water moves across driveways and lawns, it can pick up things like oil, lawn chemicals, and trash and carry them straight into our local streams. That pollution affects wildlife and can even impact our drinking water. And when rain isn't soaking into the ground like it should, our groundwater doesn't get replenished.
